

GPM Investments, LLC \$10,000 Sweepstakes OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

1. Eligibility: The GPM Investments, LLC \$10,000 Sweepstakes ("Sweepstakes") is open only to legal residents of AR, CT, DE, IA, IL, IN, KY, LA, MD, MI, MO, NC, NE, OH, OK, PA, SC, TN, TX & VA ("**Eligibility Area**"), 18 years of age or older (except 19 in NE).
